

# Lanimer Court Consent Form

## Lanimer Queen

I, the under signed, hereby confirm my agreement to the following Requirements set out by Lanark Lanimer Committee and consent to the named girl being included in the draw for forthcoming selection process.

**Named Parent/Carer must sign this form as proof of consent.**

### Requirements

1. I understand that the named girl will be available for all court rehearsals, which will commence 7 weeks prior to the Lanimers. Dates and times will be confirmed in due course by the Court Convener. The Lanimer Committee tries hard to make these on a variety of days so that no child is expected to miss 7 weeks of an activity in which they are already involved. However, it may involve missing a few. It is essential that all children from the court are in attendance as it is very difficult for all involved to rehearse without a full court.
2. I understand that I must finance all clothing, accessories and decorations. Clothing will include a White Lanimer Day Dress and a Lanimer Ball Gown.
3. I understand that it is my responsibility to arrange and display the Lanimer Dress in a shop window during the week preceding Lanimers and I should follow Lanimer Committee Guidelines governing this. Upon selection a member of the Lanimer Committee will contact you re the window. Parents **MUST NOT** contact the shops directly until advised to do so\*.
4. **I understand that named girl must be available for Photographs which will taken on 17<sup>th</sup> April 2018.** Any child unable to attend this event **CANNOT** be included in the selection process.
5. I understand that the named girl, **must be available** to fulfil all her duties during Lanimer Week. This will include:-  
Monday Evening - Shifting of the Standard Ceremony after Perambulation of the Marches  
Tuesday - Presentation by villagers at New Lanark  
Thursday - Morning Lanimer Procession, Afternoon at Castlebank, Tattoo at Cross.  
Friday Evening - Lanimer Reception  
Saturday Evening - Lanimer Ball  
Friday/Saturday Afternoon - Hospital visits  
(Please note Lanimer Week timetable is subject to change)
6. I agree that should the named girl not be elected as Queen she may be included in all other selections, eg **Chief Maid and Lady in Waiting.**
7. I understand that the successful girl will be asked to select her own Chief Maids (please include names with this form, in a sealed envelope. Consent forms must be received from these girls also, but will only be disclosed in the event of your child being chosen. The Lanimer Committee will check for receipt of these forms and will the guardian of any proposed Chief Maid who does not have a consent form)
8. I confirm that the named girl's main residence is within the town boundaries, ie a three-mile radius of the centre of Lanark. All addresses will be checked prior to selection. (Please email the court convener should you wish a copy of the detailed map.)
9. I understand that the Lanimer Committee reserves the right to de-select the named girl if she does not abide by the above requirements or engages in unruly behaviour at the Photo Session, Rehearsals or any other Lanimer Event.

Please note that the above are basic requirements. Further information will be provided on selection, which will require *another* signature. Children will not be deemed to have accepted without this documentation.

A parents' evening will be held on **2<sup>nd</sup> February 2018**, at 7pm venue to be confirmed. All court members selected must attend, accompanied by a responsible adult.

***\*After selection a member of the Lanimer Committee will contact you to select a window re point 3 above. This will secure this window for you, but you must contact the shopkeeper promptly for further details. Under no circumstances should an attempt be made to make a private arrangement prior to selection.***
