

LANIMER COURT CONSENT FORM

I, the under signed, hereby confirm my agreement to the following Requirements set out by Lanark Lanimer Committee and consent to the named girl being included in the draw for forthcoming selection process.

Named Parent/Carer must sign this form as proof of consent.

Requirements

1. I understand that the named boy will be available for all court rehearsals, which will commence 7 weeks prior to the Lanimers. Dates and times will be confirmed in due course by the Court Convener. The Lanimer Committee tries hard to make these on a variety of days so that no child is expected to miss 7 weeks of an activity in which they are already involved. However, it may involve missing a few. It is essential that all children from the court are in attendance as it is very difficult for all involved to rehearse without a full court.
2. I understand that costumes will be provided, and that said boy must be available for costume trials. I must finance shoes for all Non-riding appearances – these should be black dress shoes and NOT trainers. Riding boots and safety hats will be provided – secondary school boys only.
3. I understand that Secondary School boys will be available for all Riding Lessons, these may take place during school time, on the agreement of Mr Sherry, or at a weekend TBC. ALL secondary School Boys MUST be willing to ride without exception. Lessons adequate to walking will be provided and paid by the Lanimer Committee.
4. **I understand that named boy must be available for Photographs which will be taken on Tuesday 16th April 2019.** Any child unable to attend this CANNOT be included in the selection process.
5. I understand that names boy, **must be available** to fulfil all his duties during Lanimer Week, this will include:-
 - Thursday – Morning Lanimer Procession
 - Friday Evening – Lanimer Reception
6. I confirm that the names boy's main residence is within the town boundaries, i.e. a three-mile radius, of the centre of Lanark. If outwith this, then I must provide the Lanimer Committee with an address within this distance where the named boy can be collected for her Lanimer duties. Children will not be included in the selection process without this address on the attached form.
7. I understand that the Lanimer Committee reserve the right to de-select the named child if she does not abide by the above requirements or engages in unruly behaviour at Photo Session, Rehearsals or any other Lanimer Event.

Please note that these are basic requirements. Further information will be provided on selection, which will require *another* signature. Children will not be deemed to have accepted without this documentation.

A parents evening will be held on **1st February 2019** at 7pm, venue to be confirmed. All court members selected must attend, accompanied by a responsible adult.
